#### a. Personal Information You Provide

⚠ Please do **not** submit sensitive medical information through website forms unless explicitly instructed to do so through a secure portal.

#### b. Automatically Collected Information

When you visit our website, we may automatically collect:

- IP address
- Browser type
- Device information
- Pages visited and time spent on the site

This information is used for website functionality, security, and analytics.

### 3. How We Use Your Information

We may use the information we collect to:

- Respond to inquiries or appointment requests
- Communicate with you about our services
- Improve website performance and user experience
- Maintain website security
- Comply with legal and regulatory obligations

---

### 4. Cookies and Tracking Technologies

Our website may use cookies or similar technologies to enhance functionality and analyze traffic. You can control cookies through your browser settings. Disabling cookies may affect certain features of the website.

---

### 5. Disclosure of Information

We do **not** sell or rent your personal information.

We may share information:

- With trusted service providers who assist in website hosting, analytics, or communications
- When required by law or to protect our rights and safety
- As otherwise permitted or required under applicable healthcare and privacy laws

Any vendors with access to data are required to maintain appropriate security and confidentiality.

## **6. HIPAA and Medical Information**

If you are a patient of **HMI Foot and Ankle Group, SC**, your medical information is protected under the **Health Insurance Portability and Accountability Act (HIPAA)**.
