This contract is publically available on my website, by purchasing a Pomeranian you agree to these terms.

If you buy as a pet with the option for rights later on, I do ask that you do not breed your Female Pomeranian before their 3rd heat or your Male before 12 months. If this is ignored, I will not offer the option for full rights or I will have them revoked for a breach of contract.

***Full rights are an additional \$500**

If this Pomeranian produces a litter when sold on a pet only agreement, there will be a monetary fine of \$5,000. If this Pomeranian is offered for sale, sold, placed in a shelter/rescue without the breeder being offered first right of refusal, there will be a monetary fine of \$5,000 and an automatic repossession of the Pomeranian along with all of their paperwork.

*If returning to the breeder, no funds besides the initial deposit will be returned unless the Pomeranian is placed in another home once in the breeders possession in which 50% of the purchase price minus travel fees, boarding and vet care will be returned. The buyer is responsible for making arrangements to have the Pomeranian returned at their own expense, I will meet within a reasonable distance. Refunds will not be offered after the first 6 months of ownership.

I retain the right as the breeder to cancel a placement if for any reason I do not feel the puppy will be in a safe environment. If this happens, a refund will be offered within 30 days of cancellation. Deposits are non-refundable unless something happens to the puppy in my care, in which case a refund will be offered or the deposit to be transferred to another litter, If a refund is chosen it can take up to 30 days. If the transaction is to turn sour for any reason, you agree to not slander the breeder, post anywhere publicly, harass, have family members contact me or bring forth legal charges. This contract is legally binding. In the event that slander is posted, I will take appropriate legal action. I do my best to respond in a timely manner, however life does happen and there are times I cannot respond immediately.

Health Guarantee

The breeder, Jessica Nunn, guarantees that this Pomeranian is free from any life threatening genetic disease. This puppy will be seen by my Veterinarian prior to leaving to receive a wellness check and their first vaccine.

The breeder offers a 72 hour guarantee against life threatening diseases such as Parvo, it is your responsibility to have them seen by your Vet within those 72 hours. If the puppy is not seen within that time frame, the guarantee is voided.

The puppy comes with a 1 year health guarantee against congenital defects, it does not include the following: coat, color, weight, size, luxating patellas, bite, open fontanel, coccidia, giardia, hypoglycemia, landlord issues or accidental death.

During the initial 72 hour guarantee the buyer must notify the breeder of the diagnoses with the following information:

If the buyer decides to have the puppy treated and not return the puppy back to the breeder within the guarantee time, the buyer will be responsible for any and all medical costs and the guarantee will be voided. If the buyer returns the puppy and all the requested information must be provided as well as the AKC registration papers and all shipping charges will be the responsibility of the buyer. Under no circumstances will the breeder be responsible for any veterinary bills incurred or shipping/delivery costs.

The breeder will then have their veterinarian examine the puppy and if the breeder's veterinarian agrees to the diagnosis of a life threatening illness, the breeder will replace the puppy with another Pomeranian of the same value when one becomes available with no funds being returned.

If you are past the age of 70 or have any illness that could cause early demise, your puppy must be put into your will with an appropriate beneficiary or a stipulation requiring the puppy be returned to the breeder.

Please understand that puppies are not safe against any disease until 2 weeks after their third vaccine, placing them on any public surface can potentially put them at risk.

Please do not leave your Pomeranian outside unattended for long periods of time, they are fragile and very susceptible to heat stroke, there is also the threat of predatory animals.

If the Pomeranian passes away under any circumstances not related to a congenital defect while in their new home, the breeder will not be held responsible.

You are responsible for your transport's actions and the puppy's welfare as soon as the designated pet nanny takes possession of the puppy. If using a transport of any kind, the breeder is not responsible for the puppy once handed over to the nanny. The breeder will not be held liable for anything that could happen to a puppy while being transported including hypoglycemia. No refund will be offered if something is to happen to the puppy while being transported. Nutri-Cal will be sent in the puppy bag to help keep the puppy nourished in case of car sickness or lack of appetite.
