

## PUBLIC HEARING NOTICE

To all interested citizens of Salyersville, Kentucky;

The Kentucky Department for Government is accepting application under the 2020 Community Development Block Grant (CDBG) Program. The City of Salyersville intends to apply for assistance to rehab the existing wastewater collection system within the Salyersville city limits. The City of Salyersville will hold a public hearing prior to the submission of the application. The public hearing will be held on Monday, July 13, 2020 at 1:00 pm at the Salyersville City Hall. The purpose of this hearing is to obtain views on housing and community development needs, review proposed activities, review the proposed application and solicit public comments. Technical assistance is available to help groups representing low and moderate income persons in developing proposals.

The following information concerning the CDBG program is available for public inspection at the Salyersville Hall during regular business hours.

- A. Amount of funds available and range of activities that may be undertaken.
- B. Estimated amounts of funds proposed to be used for activities benefiting persons of low and moderate income.
- C. Plans for minimizing displacement of persons as a result of activities associated with CDBG funds and plans for providing assistance to those persons to be actually displaced as a result of CDBG funded activities.
- D. Records regarding the past use of CDBG funds.
- E. A summary of other important program requirements.

### Comments on Application

A copy of the CDBG application material will be on file at the Salyersville City Hall for citizen's review and comment during regular business hours from July 6<sup>th</sup> through July 13<sup>th</sup>. Comments on the proposed application may be submitted to the attention of James "Pete" Shepherd, Mayor, 315 E. Maple Street, Salyersville, KY 41465 until the close of business on July 13<sup>th</sup>.
