Judge-Executive Ben Hale called the meeting to order after a quorum was determined to be present. He took the liberty of acknowledging guests. The minutes from the May 24, 2016 meeting were reviewed and with a motion and a second from Mr. Millow McCarty and Judge-Executive Tucker Daniel, the minutes were approved. Motion carried. The Agenda was approved as submitted with a motion and a second by Mr. Millow McCarty and Mayor Pete Shepherd. Motion carried.

Mr. Greg Salyers gave the Financial Report. He indicated that we closed out FY16 with \$980,000 in the bank. \$383,000 is in our ED RLF account. We have a \$1.4 million fund balance. He is happy with the slight budget variances and stated all other departments are within expectation. The CDO program ended the year with a \$100,000 surplus, which will be used to augment other aging programs. The CEDS department had a deficit and the KY Works department broke even, giving us an overall surplus of \$62,000. A motion to approve the Financial Report was made and seconded by Mr. Millow McCarty and Mayor Pete Shepherd. Motion carried

There were several projects that went through Clearinghouse and the Executive Review Process. Ms. Runyon explained each one and then a motion and a second were made by Mr. Millow McCarty and Judge-Executive Tucker Daniel. Motion carried.

There was an Executive Committee Poll conducted on June 27, 2016 to approve the FY17 Cost Allocation Plan. The Plan is provided in each board member's book and ratification of that poll was approved with a motion and a second by Mayor Pete Shepherd and Mr. Millow McCarty. Motion carried.

There were three personnel recommendations addressed separately as follows:

- Ms. Melissa King Part-time Family Caregiver Coordinator motion and second made by Judge-Executive Tucker Daniel and Mayor Pete Shepherd. Motion carried.
- Ms. Misha Curnutte Economic Development Recovery Coordinator motion and second made by Judge-Executive Ben Hale and Mr. Millow McCarty. Motion carried.
- Ms. Lanette Pinson Employment Specialist Pike County motion and second made by Mr. Millow McCarty and Judge-Executive Tucker Daniel. Motion carried.

The next order of business was the recommendation of Ms. Nita Collier to fill the vacancy for a Citizen Member in Martin County. A motion and a second were made by Mayor Pete Shepherd and Mr. Millow McCarty. Motion carried.

#### **Directors Comments:**

Ms. Runyon announced the Paul Patton Statue Unveiling taking place in Pike County today from 1-3 at the bottom of the 99 in front of the college.

On August  $19^{th}$  we will be hosting the first Big Sandy Small Business Expo at the Jenny Wiley Convention Center from 10-2.

Our board meeting in August will fall during the Governor's Local Issues Conference. It was recommended that the August Board Meeting be cancelled and if we need to do business we would hold an Executive Committee meeting. A motion and a second were made by Mr. Millow McCarty and Judge-Executive Ben Hale. Motion carried.

Ms. Susan Howard told the board that the Community of Hope would be hosting a big meeting with the Casey Family Programs and explained the impact that they have had on our communities.
