Village Administrator Assistants pay will raise to \$ 16.00. He must take the water test by March 15th, 2023. Effect period beginning March 20th. NEW BUSINESS

Jessie Powers with ORCA; Campground Drawing = Athens Wayne Corporation is handling the design. The land for campground was donated to the Village of Chauncey when the mine closed. Jessie is working on the funding for the campground and any cost associated with the construction. ORCA may be willing to do a profit sharing with the village. The campgrounds will be primitive. ORCA and County Commissioner is working on funding for a maintenance worker. ORCA is working on getting \$ 500,000 from the county to hire 3 employees. Athens County is pushing back due to funding for employees that may do some work outside Athens County.

Peter Kotses with Local Business = 85 Converse St. and 2 High St sit on the same parcel. Currently Peter is redoing 85 Converse Street, total reconstruction. 85 Converse St. will become a duplex. Second phase of project will be to remove 2 High St. Once 2 High St is demolished, a new building will go up as a commercial property. Peter is not sure of what the business will be but wanted to inform council and the village. The business he believes will be seasonal and not open late at night. Peter will need a building permit for both the buildings. If zoning code is adopted by the time of construction, Peter will need a zoning permit.

Trailer Park Water/Sewer = DLZ is getting close to being able to finalize the design of the sewer line project. DLZ is running into a problem with the trailer park due to the current sewer lines being under trailers that are currently in the trailer park. The sewer lines need to be fixed/repaired. The current cost to fix the trailer park would be \$875,000. This would mean that the old sewer lines would be out of commission and new lines would be put throughout the trailer park. The new design would be to put a master meter at the beginning of the trailer park. If a master meter is put in, it would allow the village to charge for the outflow of the sewer instead of basing it on water usage. DLZ said it legally hard to get the owner to take responsibility for its own sewer line. The line to extend Plum Street water/sewer would cost around \$250,000.

Playground Color Choices = Gametime.com has great example of nature color playgrounds. Original plan was to do the playground equipment in natural colors. Council would like to see more colors in the playground. Please give the mayor color choices by Friday, March 18th. Karla and Connaught will be picking choices.

Public Records Training = Basic elected official needs to do a training once a term. April 21st is the next webinar. The council may designate officials to do the seminar on the public records training. The fiscal officer will be doing the training.

County Auditor would be willing to give a seminar/presentation on the history of the fiscal history of the village. Council would like to do the seminar/presentation with the auditor.

Solicitor was thinking with all the business going in the village, maybe the council should consider putting a police levy on a ballot.

The state passed a rule that people can set off fireworks at certain times of the year. Council may want to consider putting it on record about what they will allow.

MAYOR'S REPORT

Chris Russell JR put a request in for a pay raise via a letter for a \$2.00 an hour raise. He has received another job offer. He has only received a raise one time in the amount of \$.50 per hour. He's been with the village for about 14 months. Tucker will no longer be working for the village as of the week of March 14th. Vote was taken on the raise for the \$2.00 hour raise, AIF.

No bids for the sewer line again. DLZ to request an extension for CDBG. DLZ advised that the village will have a hard time getting a bid due to the nature of the job and the bidder to lose money.

Mine building update: Meetings have been non-stop. Meeting March 17th ODNR. Trying to receive funds to preserve the buildings. Part of one of the mine buildings will need to be take down to extend the bike path. Working on a power grant for funds. OU trying to tie in the mine buildings project into there request. Project may need to be done in stages due to funding. Power Grant has a deadline of April 1, 2022.

Jim Edwards is still looking for access to his property through the park. In order to receive any grants for the mine construction, we will need to get the property in the village name.

Chris is waiting to hear from the railroad about the right of way and if the village gets approved, the access will not have to run through the park.

COUNCIL MEMBERS REPORTS

Connaught Cullen = Clean up day this spring. This is done by the Lions Club. Village Administrator to follow up with the Lions Club.
