Mayor Tammy: Read the definition of the vacant building description to the village and village members. Mayor Tammy: Recommended that Steven Buck fill out an appeal to the zoning appeal board. Barb: Does not think it should be passed tonight since there seems to be some confusion amongst the village council members.
