## Village of Chauncey Council Meeting on December 18, 2018 Meeting Minutes

**CALL TO ORDER-**The Mayor Robert Mattey called the meeting to order at 5:30 PM at Village Hall.

<u>PLEDGE TO FLAG-</u> Observed by all in attendance.

ROLL CALL- Taken by Fiscal Officer: Seat 1-Joe Canter present; Seat 2- Vacant; Seat 3-Tammy Hawk present; Seat 4- Amy Renner present; Seat 5- Larry Pierce absent; Seat 6- John Canter, President of Council, present. Joe Canter moved to excuse Councilman Pierce with a second from Tammy Hawk. AlF passed.

<u>APPROVAL OF BILLS-</u> Village bills were reviewed by Council members. Moved by Tammy Hawk and seconded by John Canter that the bills be paid. AIF passed.

<u>APPROVAL OF MINUTES OF PRIOR MEETING(S)-</u> Meeting minutes for October 16, 2018 Council Meeting were reviewed by Council. Moved by Joe Canter to approve the minutes; second by Amy Renner-AIF approved.

<u>APPROVAL OF FINANCIAL REPORT AND REPORT FROM FISCAL OFFICER-</u> Financial report for November 2018 were provided to Council members for review. Moved by Tammy Hawk to approve the Financial Report. Second by Joe Canter. AlF passed. Fiscal Officer reports that the 2016 and 2017 Audit is ongoing. She also reports that Postage will be increasing from 50 cents a stamp to 55 cents per stamp.

## **ORDINANCES AND RESOLUTIONS-**
