

**RESOLUTION OF NECESSITY** 2026-05  
 RESOLUTION REQUESTING CERTIFICATION FROM COUNTY AUDITOR  
 PURSUANT TO OHIO REVISED CODE SECTION 5705.03  
 (Dollar amount of revenue generated by specified number of mills)

WHEREAS, the Council of Village of Chauncey, Athens County, Ohio, determines that it is necessary to levy a tax outside the ten-mill limitation, and

WHEREAS, before seeking to have a levy approved by the electors of Village of Chauncey the Council must seek the certification of the Athens County Auditor in compliance with Section 5705.03 of the Ohio Revised Code, submitted for the General election held on November 3<sup>rd</sup> 2026

THEREFORE, BE IT RESOLVED, by the Council of Village of Chauncey, Athens County, Ohio, that the Athens County Auditor is hereby requested to certify to the Council:

- The total current tax valuation of Village of Chauncey, and
- The dollar amount of revenue that would be generated by 5 mills.

BE IT FURTHER RESOLVED that the purpose of the tax is Current Expenses

And is for 5 yrs, being first levied in tax year 2026, first collected in calendar year 2027 and appearing on the tax list for the years specified: 2026-2030

Such tax is authorized to be submitted to a vote of the electors of the Village of Chauncey pursuant to Section 5705.19(A) of the Ohio Revised Code, and shall be levied on the residents of the Village of Chauncey pursuant to Section 5705.19(A) of the Ohio Revised Code and which shall be Renewal of Current Expenses. List any other county into which this subdivision overlaps: None

BE IT FURTHER RESOLVED that the Athens County Auditor is requested to issue the certification within ten days after receiving this Resolution.
