AN ORDINANCE AMENDING ORDINANCE NO. 2011-1, 2 PASSED JANUARY 18, 2011 AND SEPTEMBER 20, 2011, ENTITLED "APPROPRIATION MEASURES AND REVENUE PROJECTIONS FOR THE VILLAGE FOR THE YEAR 2011 PURSUANT TO R.C. 5705" SO AS TO AMEND EXHIBIT A THERETO, "APPROPRIATIONS," TO ELIMINATE NON-ESSENTIAL REFERENCE TO NON-APPROPRIATED FUNDS; AND DECLARING EMERGENCY

BE IT ORDAINED by the Council of the Village of Chauncey, State of Ohio as follows:

Section One: The attached Exhibit A prepared by the Fiscal Officer shall be the amended reduction of the 2011 Certificate of Estimated Resources and the amended reduction of the 2011 Appropriations for the Capital Project Funds.

Section Two: This Ordinance is to be retroactive as of December 31, 2011.

Section Three: This Ordinance being necessary for the fiscal well-being of the Village of Chauncey and necessary to allow continuation of receipts and expenditures without interruption, it is declared to be an emergency measure and shall take effect immediately upon passage.
