

**VILLAGE OF CHAUNCEY
RESOLUTION NO. 2012-21**

A RESOLUTION COMMENDING ROCKY BRANDS, INC., THE ROCKY BRANDS ASSOCIATES, ROCKY COMMUNITY IMPROVEMENT FUND (RCIF), AND CHAUNCEY-DOVER LIONS CLUB AND ITS MEMBERS FOR THEIR GENEROUS ACCOMPLISHMENTS IN MAKING THE VILLAGE OF CHAUNCEY, OHIO AND DOVER TOWNSHIP BETTER PLACES TO LIVE

WHEREAS, Rocky Brands, Inc., a very successful manufacturer in Nelsonville, Athens County, Ohio that has employed residents in the local area (Associates) since its founding in 1932, and the Rocky Brands Associates have committed to the improvement of Nelsonville and its surrounding communities; and

WHEREAS, in order to give back to Nelsonville and its surrounding communities, in 2009 Rocky Brands, Inc. created Rocky Community Improvement Fund (RCIF) to receive individual donations from Rocky Brands Associates that are matched by corporate donations from Rocky Brands, Inc. in order for RCIF to extend grants to important non-profit organizations and causes in Nelsonville and its surrounding communities; and

WHEREAS, Chauncey-Dover Lions Club is a service organization formed in 1974;

WHEREAS, the Members of Chauncey-Dover Lions Club are devoted to the betterment of the Village of Chauncey and surrounding Dover Township; and

WHEREAS, Chauncey-Dover Lions Club and its Members prepared and submitted to RCIF a grant application to improve the Shelter House Pavilion in Chauncey-Dover Community Park, a former strip mine, by replacing the roof of that structure; and

WHEREAS, in the Spring of 2012, RCIF awarded a grant of requested funds to Chauncey-Dover Lions Club, being one of nine non-profit organizations to receive such grants, which funds have been applied efficiently and prudently by its Members to replace the roof of the Chauncey-Dover Community Park Shelter House Pavilion; and

WHEREAS, the efforts of Rocky Brands, Inc., the Rocky Brands Associates, Rocky Community Improvement Fund (RCIF), and Chauncey-Dover Lions Club and its Members have improved the quality of life and community pride of all who live and work in Chauncey and Dover Township;
