**A RESOLUTION ACCEPTING THE VILLAGE OF CHAUNCEY  
DRINKING WATER SOURCE PROTECTION PLAN**

**WHEREAS;** the protection of the source of groundwater which provides the citizens of the Village of Chauncey is of utmost importance to the health, safety and security of the residents and users of the water provided by the Village of Chauncey;

**THEREFORE, BE IT RESOLVED** by the Council of the Village of Chauncey, State of Ohio, as follows:


Section One: The Village of Chauncey is required to create and maintain a Drinking Water Source Protection Plan by State law and the Ohio Environmental Protection Agency.

Section Two: The Village of Chauncey formed a Protection Team and included in the Plan:  
-Listed potential contaminant source strategies;  
-Created and education and outreach program and ideas;  
-Updated Public Service Department's annual Contingency Plan;  
-Defined terms of the update of the Plan.


Section Three: The Village of Chauncey will forward a copy of the Drinking Water Source Protection Plan to OEPA and maintain a copy of the Plan at Village Hall and the water plant.


Section Four: The matter of drinking water protection being of critical importance this resolution is passed as an emergency measure and shall go into effect at the earliest moment allowed by law.
