VILLAGE OF CHAUNCEY ORDINANCE NO. 2017-3

AN ORDINANCE CREATING THE POSITION OF ON-CALL CONSULTANT TO THE VILLAGE

WHEREAS, the current Village Administrator has resigned to take a better position, but is willing to work as a contractual on-call consultant to the Village to use his skills and knowledge to teach, assist and transfer his institutional memory to the current employee who will become an assistant to the Village Administrator and to a new Village Administrator appointed by the Mayor with the consent of the Council.

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Chauncey, State of Ohio, as follows:

Section One: There is created the position of On-call Consultant to the Village, to be filled by the former Village Administrator or a qualified person who shall provide services on a part-time basis as the Mayor, based on the needs of the Village, in his prudent discretion determines from time to time.

<u>Section Two:</u> The on-call Consultant to the Village shall be paid \$20.00 per hour thereof, for each hour or fraction thereof worked at the Village, provided however, the minimum payment shall be for two hours whenever Consultant is called to and for work in the Village.

Section Three: The On-call Consultant position created herein is a part-time employee of the Village who shall perform his/her duties for any specific task requested to be performed by the Mayor or Village Administrator. Payment shall be made by the Fiscal Officer to On-call Consultant within the pay period after the On-call Consultant submits hours worked. The Mayor shall approve in writing the hours for which Consultant seeks payment before Fiscal Officer issues payment.

Section Four: Because of the need to provide continuing competent municipal services to the residents of the Village during the transition period of appointment of a new Village Administrator and that person becoming knowledgeable of the procedures and requirements of the position, this Ordinance is declared to be an

emergency necessary to the health and welfare of Village residents, this ordinance will take effect immediately upon passage.
