

**VILLAGE OF CHAUNCEY  
RESOLUTION NO. 2017-7**

**A RESOLUTION AUTHORIZING THE FISCAL OFFICER TO ACT AS  
WATER CLERK TEMPORARILY AND SETTING HER HOURLY  
COMPENSATION.**

**WHEREAS, the Village water department billing clerk has abruptly quit her job; and,**

**WHEREAS, the Village Fiscal Officer has the capabilities to perform and discharge the duties of the water billing clerk until a replacement can be hired;**

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Village of Chauncey, State of Ohio, as follows:

Section One: The Village Fiscal Officer is authorized to perform the duties of the Village water clerk until a replacement water clerk is hired.

Section Two: The Village Fiscal Officer shall document her hours performing the duties of the water clerk and shall submit the hourly record for each day worked as water clerk to the Village Administrator or in his absence to the Village Mayor, for approval and payment.

Section Three: The Fiscal Officer shall be paid \$9.95 per hour (or fraction thereof) for each hour worked as water clerk.

Section Three: This Resolution is an emergency measure necessary for the proper operation of Village administration of the Water and Sewer Department and billings and payments for such service to and in protection of the Village residents' health and welfare, consequently this Resolution shall take effect immediately upon passage.
