

Resolution/Ordinance No. 2018-2

A RESOLUTION/ORDINANCE TO ADOPT THE SOLID WASTE MANAGEMENT PLAN FOR THE ATHENS-HOCKING SOLID WASTE DISTRICT

WHEREAS, the Village of Chawcey (city, village, township or county commission) in Athens County is located within the Athens-Hocking Solid Waste District.

WHEREAS, the Athens-Hocking Solid Waste District Policy Committee prepared and adopted a final draft of the Solid Waste Management Plan in accordance with Ohio Revised Code Sections 3734.53 3734.54 and 3734.55.

WHEREAS, the Athens-Hocking Solid Waste District has provided a copy of the Adopted Solid Waste Management Plan for ratification to each of the legislative authorities of the District.

WHEREAS, the Village of Chawcey (name of county, city, village, township) must decide whether it approves of said Solid Waste Management Plan within ninety days of receipt of the Final Draft Plan.

That it is found and determined that all formal actions of this Council (Board, council or trustees) concerning and relating to the passage of this resolution/ordinance were adopted in an open meeting of this Council (Board, council or trustees) and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements including Sections 121.22 of the Ohio Revised Code.
