**A RESOLUTION RENEWING THE SOLICITOR'S CONTRACT FOR THE  
YEARS 2018 THROUGH 2019.**

**WHEREAS, ORC 733.48 AUTHORIZES VILLAGE COUNCIL TO  
PROVIDE LEGAL COUNSEL FOR THE VILLAGE; AND,**

**WHEREAS, COUNCIL AND THE MAYOR AND ROBERT J. SHOSTAK,  
THE CURRENT SOLICITOR, AGREE TO CONTINUE THE CONTRACT  
APPOINTING ROBERT J. SHOSTAK AS VILLAGE SOLICITOR FOR  
2018-2019:**

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Village  
of Chauncey, State of Ohio, as follows:

Section One: Effective on the first day of January, 2018 and ending on the  
last day of December, 2019, the contract for Robert J. Shostak  
to act as Village Solicitor is renewed on the same terms,  
conditions, responsibilities, authority and benefits as set forth in  
the Solicitor's contract for the term 2016-2017.

Section Two: The Fiscal Officer is authorized to pay the Village Solicitor the  
same remuneration as in the previous two years for the  
extended term 2018-2019.

Section Three: This Resolution is an emergency measure necessary for the  
proper and efficient and legal operation of Village  
administration through the provision of legal services and  
advice by the Solicitor to the Village and its Officers for the  
effective day to day operation of the Village and the services it  
provides to its residents, and for the on-going matters related to  
the Village Park, proposed bike path and mountain bike trails  
proposed by the State and Wayne National Forest, and it being

necessary for the protection of Village residents' health, safety and welfare, consequently this Resolution shall take effect immediately upon passage.




