

**VILLAGE OF CHAUNCEY  
RESOLUTION NO. 2020-2**

**A RESOLUTION CREATING THE POSITION OF AN  
ON-CALL CONSULTANT TO THE VILLAGE FISCAL OFFICER**

WHEREAS, the current Fiscal Officer has resigned to take a better position, but is willing to work as a contractual on-call consultant to the Village to use her skills and knowledge to teach, assist and transfer her institutional memory to the current employee who will become an assistant to the Fiscal Officer and a new Fiscal Officer be appointed by the Mayor with the consent of the Council,

**NOW THEREFORE, BE IT ORDAINED** by the Council of the Village of Chauncey, State of Ohio, as follows:

Section One: There is created the position of On-call Consultant to the Village, to be filled by the former Fiscal Officer or a qualified person who shall provide services on a part-time basis as the Mayor, based on the needs of the Village, in her prudent discretion determines from time to time.

Section Two: The on-call Consultant to the Village shall be paid \$15.00 per hour thereof, for each hour or fraction thereof worked at the Village, provided however, the minimum payment shall be for two hours whenever Consultant is called to and for work in the Village.

Section Three: The On-call Consultant position created herein is a part-time employee of the Village who shall perform her duties for any specific task requested to be performed by the Mayor or Fiscal Officer. Payment shall be made by the Fiscal Officer to On-call Consultant within the pay period after the On-call Consultant submits hours worked. The Mayor shall approve in writing the hours for which Consultant seeks payment before Fiscal Officer issues payment.


Section Four: Because of the need to provide continuing competent municipal services to the residents of the Village during the transition period of appointment of a new Fiscal Officer and that person becoming knowledgeable of the procedures and requirements of the position, this Resolution is declared to be an emergency




necessary to the health and welfare of Village residents, this Resolution will take effect immediately upon passage.




