

**VILLAGE OF CHAUNCEY

ORDINANCE NO. 2020-6**

**AN ORDINANCE APPROVING THE VILLAGE OF CHAUNCEY COVID-19 RENT / MORTGAGE / UTILITY EMERGENCY RELIEF GRANT PROGRAM; AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT WITH HOCKING ATHENS PERRY COMMUNITY ACTION (HAPCAP) TO ADMINISTER SAID PROGRAM; AND DECLARING AN EMERGENCY.**

**WHEREAS**, the COVID-19 crisis has severely impacted many local residents who are struggling to pay their rent or mortgage due to loss of employment; and

**WHEREAS**, the Village of Chauncey COVID-19 Rent / Mortgage / Utility Emergency Relief Grant Program (“the Program”) is being created to assist Village of Chauncey residents who have been adversely affected by the COVID-19 pandemic and have demonstrated a financial need; and

**WHEREAS**, the Village wishes to partner with HAPCAP to manage the Program in an amount not to exceed \$11,000.00 as set forth in Exhibit “A”;


**BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CHAUNCEY, OHIO:**

SECTION I: Athens Village Council hereby approves the Village of Chauncey COVID-19 Rent / Mortgage / Utility Emergency Relief Grant Program, a copy of said guidelines are attached hereto and incorporated herein as Exhibit “A.” Said guidelines may be amended from time to time in a manner not materially adverse to the Village.

SECTION II: The Mayor is hereby authorized to enter into an agreement with HAPCAP to administer said Program, a copy of which is attached hereto and incorporated herein as Exhibit “B,” in an amount not to exceed \$11,000.00 in assistance grants of up to \$1,000.00 for eligible Village of Chauncey residents who have demonstrated a financial need for rent and mortgage payments, and using substantially the same guidelines as the attached Exhibit “A.”

SECTION III: The Fiscal Officer is hereby authorized and directed to make the appropriate entries and issue warrants/vouchers pursuant thereof.


