### MEMORANDUM

RE:	Indigent Defense Reimbursement Updates

This memorandum is intended to provide further guidance on one of the options the Office of the Ohio Public Defender (OPD) has offered to counties – reimbursement submission extensions – in an effort to provide support and assistance during the COVID-19 pandemic, as well as an update on reimbursement requirements for municipal ordinance contracts.

#### **Reimbursement Submission Extension**

In an <u>April 14, 2020 memorandum</u>, the OPD provided information regarding financial disclosure forms, interim billing, billing for arraignments, and extensions on the timelines for reimbursement submissions. The OPD issued a subsequent <u>memorandum on August 25, 2020</u> continuing all provisions of the April 14, 2020 memo, noting that the extension provision will be continued through December 2020. As we continue to make the extension provision available, the OPD believes it may be helpful to counties to have further guidance on extensions – specifically a chart which details when/what is considered timely.

Accordingly, attached to this memo is a document which includes two charts. The first chart details the deadline for standard reimbursement submissions (within 90 days of the end of the month in which a case was disposed – or the last court hearing for an interim bill). The second chart details the deadline for extension reimbursement submissions.

The process for extensions, as described below, allows a county to submit one regular/standard submission and one extension submission each month. A county must request an extension for any given month on or before the last day of that respective month. Then, as detailed in the chart, a county may have an additional 60 days to submit reimbursement submissions to OPD for that particular month. For example, a regular/standard reimbursement submission for the month of September (postmarked by September 30, 2020) could include bills/fee applications that have disposition dates as far back as June 2020 (which would fall within the 90-day rule). Bills/fee applications that have a disposition date of May 2020 or earlier would be untimely (fall outside the 90-day rule). If a county wished to have an extension submission for the month of September, the county should notify OPD. The county would then be permitted to send one extension submission packet to the OPD, that includes all material that would have otherwise been timely for a September submission, by November 2020 (postmarked by November 30, 2020).

The process for extensions is as follows:

- A county auditor, or their designee, should notify OPD's Reimbursement Program Administrator, Alice Hill, in writing via email (<u>alice.hill@opd.ohio.gov</u>), of an extension request for a reimbursement submission for a given month, on or before the last day of that respective month.
- Because the OPD receives and processes approximately 13,000 -14,000 indigent defense bills each month, we ask that counties submit reimbursement submissions timely, as you are able.
- 3. A county is permitted to have one timely reimbursement submission, and one "extension" submission through December 2020. As noted in the attached chart, the extension submission for the month of August will be due by the end of October. The extension submission for the month of September will be due by the end of November. The extension submission for the month of October will be due by the end of December. The extension submission for the month of November will be due by the end of December. The extension submission for the month of November will be due by the end of January. The extension submission for the month of December will be due by the end of February.
- 4. With both the timely submission and the extension submission, counties should include an appointed counsel summary report (the same that is otherwise required with each reimbursement submission).

### **Municipal Ordinance Contracts**

For those counties that have municipal ordinance contracts with any village or municipality, OAC 120-1-09 previously required the OPD to approve those contracts through signature. In an effort to assist counties, the OPD has amended OAC 120-1-09 to now require that counties send executed municipal ordinance contracts to the OPD within 60 days of execution. The OPD will no longer be signing those contracts as to form, which should prove a more efficient process for the involved parties.
