## VILLAGE OF CHAUNCEY STATE OF OHIO RESOLUTION NO. 2021-6

## A RESOLUTION TO SALVAGE CERTAIN BRICKS AND TILE FROM ON-GOING PROJECTS WITHIN THE VILLAGE

- WHEREAS, The Village is replacing a portion of the sidewalk of Converse Avenue with new concrete and is taking up the old sidewalk made of bricks made in the old Athens Brick Works, which bricks have historical significance and value, and;
- WHEREAS, The Baileys Mountain Bike Trail System trailhead improvement Project through a state of Ohio grant is taking down the old mining building located on Village lands adjacent to Chauncey Park Trailhead, which building is clad with glazed clay tile which Council believes may be used in a community beautification or art project,
- **NOW THEREFORE, BE IT RESOLVED** by the Council of the Village of Chauncey, State of Ohio, as follows:
- Section One: The Village Administrator is authorized to arrange to have the historical bricks once dug up transported to the Texas Eastern property owned by the Village and placed in a pile for further use or sale.
- Section Two: The Village Administrator is authorized to arrange to have as much of the glazed clay tile from the old mining building as would constitute about a pickup truck load loaded onto a truck and transported to the Texas Eastern property and placed in a pile for the future use of the Village Council.
- Section Three: The pile of bricks and pile of clay tile shall be kept as neat as may be practicable so that these piles do not become a haven for vermin, rodents, snakes and otherwise become unsightly and a nuisance to the Village. In the event that the contemplated uses of the bricks and tile is not accomplished within one year after they arrive on the property, the Village Administrator, after

informing the Council of intention to dispose, is authorized to dispose of said bricks and/or tile by having them taken to an appropriate disposal site unless otherwise decided by Council by Resolution prior thereto.

<u>Section Four:</u> Because the work on the projects referred to herein is ready to begin, this Resolution is declared to be an emergency enactment and the three reading requirement is suspended and waived as provided in ORC 731.17. This Resolution shall take effect immediately upon passage.
