A RESOLUTION SETTING FORTH CHANGES IN CONDITIONS OF CONTINUED EMPLOYMENT OF PART-TIME LABOR POSITION

WHEREAS, THE VILLAGE OF CHAUNCEY DEEMS IT IMPORTANT THAT VILLAGE EMPLOYEES RECEIVE FAIR TREATMENT AND BE AWARE OF CONDITIONS OF EMPLOYMENT;

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Chauncey, State of Ohio, as follows:

Section One: Brody Bobo, employed as a part-time helper and assistant to the

Village Administrator, has expressed his desire to continue his employment with the Village with possibility of full-time

employment and commensurate pay increases.

Section Two: Beginning October 10, 2019, Brody Bobo shall serve a thirty-

day probationary period and if evaluated and approved by the Village Administrator, will be employed as a full-time employee under the direction of the Village Administrator. On October 10, 2019 Brody Bobo shall receive a \$1.00 per hour

raise during his thirty-day probationary period.

Section Three: On or about November 14, 2019, if approved by the Village

Administrator, Brody Bobo will be employed in a full-time capacity under the supervision of the Village Administrator. Brody Bobo's pay will be increased by \$1.00 per hour when he

becomes a full-time employee.

Section Four: For a period of 120 days beginning on the first day of Brody

Bobo's full-time employment, he shall serve a probationary period for purposes of evaluation of his suitability to continue to be a full-time employee of the Village. The Village Administrator shall observe and evaluate Brody Bobo. During this probationary period, The Village Administrator or Mayor

may terminate Brody Bobo's employment for any reason. If Brody Bobo is recommended by the Village Administrator to Council to continue to be employed full-time at the end of the probationary period, Brady Bobo will receive an increase in his hourly wage pay of \$1.00.

Section Five:

This Resolution is declared to be an emergency measure to ensure that the Village has sufficient employees to carry out the governmental services provided by the Village and therefore necessary for the health, safety and welfare of the residents of the Village, consequently this Resolution shall take effect immediately upon passage.
