
**WHEREAS**, the Village has intent to utilize outside funding for a portion(s) of the Project.

**NOW, THEREFORE BE IT RESOLVED BY THE Council OF THE Village of Chauncey, Athens County, OHIO:**



That the Village of Chauncey tentatively award the Sanitary Sewer Improvements – Phase 2 contract to Fields Excavating, Inc. in accordance with the Engineer’s Letter of Bid Recommendation, attached hereto and incorporated herein by reference, subject to final approval of funding agencies of the Project.
2. The foregoing Ordinance was adopted in open session to the public and complies with all applicable legal requirements.
3. This Ordinance is being passed as an emergency measure to preserve the health and safety of the public in relation to the Project and to accommodate the timely completion of the bidding and contracting processes of this body, the State, and funding agencies.

Duly enacted by Council on first reading under suspension of the rules on this 12<sup>th</sup> day of September, 2024.




