RESOLUTION NO. 2020-15**

A RESOLUTION AMENDING THE PERMANENT APPROPRIATION ORDINANCE FOR THE SUPPLEMENTAL APPROPRIATION PROVIDED BY THE CORONAVIRUS AID, RELIEF AND ECONOMIC SECURITY ACT(CARES ACT) AND DECLARING AN EMERGENCY

WHEREAS, before receiving a payment of funds, a subdivision is required to adopt a resolution affirming that the subdivision will appropriate, encumber and spend the funds only on pandemic-related expenses as required under the CARES Act; and

WHEREAS, any funds remaining unencumbered as of October 20, 2020 or as may be extended, are required to be returned to the County Auditor; and


NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Chauncey, Athens County, Ohio, that;

Section 1: The Appropriation Ordinance for the year 2020 is hereby amended and the Fiscal Officer is authorized to establish the following appropriations to the Coronavirus Relief Fund (see Resolution 2020-11) provided in attached **Exhibit A** from the County Auditor's Office.






