A RESOLUTION AUTHORIZING THE MAYOR TO INTERVIEW AND HIRE A CODE INSPECTOR OFFICER TO ADMINISTER THE CHAUNCEY ZONING CODE AND DECLARING AN EMERGENCY

WHEREAS, the Village of Chauncey has duly adopted the Village of Chauncey Zoning Code to govern and regulate land use within the corporation limits of the Village of Chauncey, Ohio; and

WHEREAS, Section 1.11 of the Village of Chauncey Zoning Code established the Office of Code Inspector to enforce the Zoning Code in accordance with the administrative provisions of the Zoning Code; and

WHEREAS, there is an immediate need for the Village of Chauncey to seek out and hire a suitable person to serve as Code Inspector Officer to enforce the Zoning Code,

NOW THEREFORE, IT IS RESOLVED BY THE COUNCIL OF THE VILLAGE OF CHAUNCEY AS FOLLOWS:

Section 1. The Mayor is hereby authorized to solicit applications from persons interested and qualified to be hired for the position Village of Chauncey Code Inspector Officer, to interview such suitable candidates for the position as the Mayor deems appropriate in her sole discretion, and to immediately hire the most qualified candidate, taking into account the credentials and suitability of each candidate who applies and is interviewed.

Section 2. This Resolution is declared to be an emergency measure because it is necessary to health, safety, and welfare of the Village that the Village be able

administer and enforce its Zoning Code to encourage and protect the value of the various properties located in the Village and to protect the property rights of each property owner.
