#### **NEW BUSINESS:**

Registration and Fees until January 31. Mike Kraus: We passed this in December of 2023. What is the difference in this one. Evelyn Nagy: There was adjustment to the fees and caping the fees. This was sent to the planning and development committee. The planning and development did not come up with a clear decision (minutes from Planning and Development committee is attached for reference). Drew worked with Amy on this ordinance, the original ordinance was duplicated for the City of Painesville. Most vacant building within the village are exempt already. 15 out of 27 are already exempt. Drew believes if we put the fees to high, people will not be able to afford to fix the homes up. Barb asked why are we comparing us to a city of over 20k people. She just wanted to make that known. Drew: this is not peoples first home. This is an additional home. Karla Dellinger: I think we are making it harder for the small people since we have Capstone in the area. Karla's recommendation is cap it at 4 years. Debbie: I would like to see these homes turned into affordable properties in the area since there is a housing shortage in the area. Mike to Debbie: Do you think the fees are effective? Debbie does not believe the fees are effective. Council asked for Drew to send them a word document to their email. Connaught Cullen asked what the exemption are. Drew read the exemptions to the council.

<u>Resolution 2025-8 Special election on November 4<sup>th</sup>, 2025 to file the office of the mayor.</u> Evelyn introduced. Karla Dellinger seconded. First reading. Jonathan will email everyone a copy.
