RESOLUTION DECLARING IT NECESSARY TO LEVY A TAX IN
EXCESS OF THE TEN MILL LIMITATION UNDER OHIO REVISED CODE §§
5705.19; .191; .192; .194; .21; .26; AND REQUESTING CERTIFICATION
OF ESTIMATED TAX REVENUE

The Village Council of the Village of Chauncey met in Special Session by Zoom Conference on the date set forth with the following members marked present:

Member Diana Burritt introduced and moved
consideration of the following Resolution No. 2021-19,
Whereas, the amount of taxes which may be raised within the ten mill limitation
will be insufficient to provide an adequate amount for the necessary expense
requirements of the Village of Chauncey, County of Athens;
Therefore it is Resolved, by the Village of Chauncey Council members elected
thereto and Concurring, that it is necessary to levy a tax in excess of the ten mill
limitation for the benefit of the Village of Chauncey for the purpose of
CURRENT EXPENSES.

Ohio Revised Code Section authorizes the purpose in 5105.19(A).

This levy is a RENEWAL;

At a rate not exceeding 5.00 mills for each one dollar of valuation, which amounts
to 0.50 Cents for each one hundred dollars of valuation for FIVE (5) years.

Commencing in 2021 (first year levy will be levied)

First due in the calendar year 2022 (first calendar year in which the tax will be due)

Be it further Resolved, that the question of levying additional taxes be submitted to the electors of the Village of Chauncey at the General Election to be held at the usual places within the said Village of Chauncey on November 2, 2021; and be it further;

Resolved, that this Resolution of Necessity be and is hereby certified to the Athens County Auditor for issuance of a Certificate of Estimated Tax Revenue and for further action on the renewal levy aforesaid as required by law,

ATTACHED IS A COPY OF THE COUNTY AUDITOR'S CERTIFICATE OF ESTIMATED TAX REVENUE

AND BE IT FURTHER RESOLVED, That said levy be placed upon the tax list of the current year after the February Settlement next succeeding the election, if majority of the electors voting thereon vote in favor thereof; and be it further;

RESOLVED, That the Fiscal Officer of the said Village of Chauncey, County of Athens, Ohio, shall thereafter certify to the Board of Elections the Resolution of the Village Council to cause notice of election on the question of levying said tax be given as required by law.

It was moved by Diana Burritt to adopt and seconded by Tammy Hawk on the motion and the roll being called upon its adoption the vote resulted as follows:




