**A RESOLUTION DECLARING A NECESSITY OF EMERGENCY FOR  
THE APPROPRIATION OF FUNDS INTO THE STREET FUND AND  
PERMISSIVE MOTOR VEHICLE TAX FUND.**

**WHEREAS**, Council has been informed by the Village Administrator that storm drain work needs complete on Ellis Avenue.

**WHEREAS**, Council has been informed by the Village Administrator that the this project is of an emergency need to complete so it can be fixed before any street work.

**WHEREAS**, the estimated cost of emergency storm drain work on Ellis Avenue is \$19,790; and,

**WHEREAS**, the funds best qualified to pay for this emergency project are the Street Fund and the Permissive Motor Vehicle Fund, which neither can be used until the funds are appropriated.


**NOW THEREFORE, BE IT RESOLVED** by the Council of the village of Chauncey, State of Ohio, as follows:

Section One:           The estimation of \$19,790.00 is accepted as a good faith and reasonable estimate for the emergency storm drain project.


Section Two:           Upon careful deliberation Council approves the appropriation of \$9,790 from the Street Fund and \$10,000 from the Permissive Motor Vehicle Tax Fund. Therefore, Council authorizes the Fiscal Officer to pay for the storm drain work once it is completed, invoiced and approved for payment by the Village Administrator and Mayor.




