**A RESOLUTION AUTHORIZING THE MAYOR AND  
SOLICITOR TO NEOGIOTATE AND ENTER INTO A  
CONTRACT FOR A VILLAGE PROSECUTOR**

**WHEREAS**, it is necessary for the Village of Chauncey to engage an attorney at law to serve as Village Prosecutor; and,

**WHEREAS**, Ohio Revised Code Section 705.11 authorizes the Village Solicitor to engage an assistant who may serve as Village Prosecutor, and

**WHEREAS**, the necessity for the Village of Chauncey to engage a new Village Prosecutor is immediate,

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Village of Chauncey, State of Ohio, as follows:

**Section 1.** The Mayor and Solicitor are hereby authorized to negotiate a contract with a qualified attorney at law to serve as Prosecutor for the Village of Chauncey and to prosecute misdemeanor criminal actions filed by and in the name of the Village of Chauncey before the Athens County Municipal Court. Such negotiations shall be subject to any restrictions or conditions set forth herein.

**Section 2.** The Prosecutor shall be paid a monthly salary in accordance with the Agreement negotiated by the Mayor and the Solicitor. The Prosecutor's salary shall constitute fully creditable PERS service.

**Section 3.** The Prosecutor so appointed shall exercise such duties as assigned by the Solicitor to prosecute misdemeanor criminal actions filed by and in the name of the Village of Chauncey before the Athens County Municipal Court.

**Section 4.** The Mayor, Solicitor, and Fiscal Officer of the Village of Chauncey, Ohio are hereby authorized and directed to execute a contract on behalf of the Village for employment of a Prosecutor, for a monthly salary of up to \$750 per month. The contract shall be for a term of not more than 2 years.

**Section 5.** This Resolution shall be in full force and effect at the earliest time permitted by law.






