A RESOLUTION DETERMINING THE BEST BID FOR THE CHAUNCEY STREETSCAPE REVITALIZATION PROJECT AND AWARDING A CONTRACT RELATING THERETO AND DECLARING AN EMERGENCY

WHEREAS, the Village of Chauncey had previously publicly advertised for sealed bids to be tendered to the Village for the Chauncey Streetscape Revitalization Project ("Project"); and

WHEREAS, two bids were tendered to the Village within the period for tendering any bid to the Village; and,

WHEREAS, McKee Paving and Sealing, LLC submitted a bid in the amount of \$1,509,300.00 for the Project; and,

WHEREAS, the McKee Paving and Sealing, LLC bid was the lowest and best bid tendered to the Village; and,

WHEREAS, accepting the McKee Paving and Sealing, LLC bid and awarding the contract for the Project in accordance with that bid is in the best interest of the Village of Chauncey;

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Chauncey, State of Ohio, as follows:

Section 1. Council hereby determines that the bid of McKee Paving and Sealing, LLC for the Chauncey Streetscape Revitalization Project ("Project") is the lowest and best bid received after advertising in accordance with applicable law.

Page 1 of 4 Resolution 2025-11 **Section 2.** The Village Administrator is hereby authorized to enter into a contract with McKee Paving and Sealing, LLC for the Project, in accordance with the specifications and terms upon which the bid was received by the Village, as set forth in **Exhibit A**, a copy of which is attached hereto by reference in its entirety for all purposes.

Section 3. The cost of the contract shall be paid out of funds appropriated for by Council, using grant funds received by the Village for the Project.

Section 4. Council hereby finds all of its deliberations relating to this Resolution and to the award of the contract authorized herein were conducted in compliance with the Ohio Open Meetings Act and other applicable law.

Section 5. It is the purpose of this Resolution to ensure construction can begin as soon as possible as the current construction season is already ongoing and the project needs to be completed during construction season and therefore this Resolution is deemed an emergency measure necessary to protect the safety, health and welfare of the Village residents and shall take effect immediately upon passage.

This Resolution is passed on suspension of the three readings requirement set forth in ORC 731.17 by vote of three-fourths of Council members, and shall take effect immediately upon passage.
