RESOLUTION NO. 2020-9

A RESOLUTION DIRECTING THE ATHENS COUNTY BOARD OF ELECTIONS TO CONDUCT THE ELECTION OF THE PROPOSED MUNICIPAL INCOME TAX FOR THE VILLAGE OF CHAUNCEY, OHIO, IN THE GENERAL ELECTION ON NOVEMBER 3, 2020

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Chauncey, State of Ohio, as follows:

Section One: The legislative authority, the Council of the Village of Chauncey, proposes to enact a levy for municipal income tax as authorized by Article XII, Section 3(B) of the Ohio Constitution, and by Ohio Revised Code Sections 718.01 to 718.10.

Section Two: The rate of the proposed income tax levy is one and one-half percent. The proposed Ordinance is attached hereto.

Section Three: Ohio Revised Code Section 718.04 (C) requires that any municipal tax on income in excess of one per cent must be submitted for approval of the excess by a majority of the electors of the Village of Chauncey voting on the question at a general, primary or special election.

Section Four: The Council of the Village of Chauncey directs the Board of Elections of Athens County to submit the ballot to the electors of the Village of Chauncey in the form set forth below:




