Section One:

Section Two:

The rate of the proposed income tax levy is one and one-half percent. The proposed Ordinance is attached hereto. -4 2020-4

Section Three;

Ohio Revised Code Section 718.04 (C) requires that any municipal tax on income in excess of one per cent must be submitted for approval of the excess by a majority of the electors of the Village of Chauncey voting on the question at a general. primary or special election.

Section Four:

The Council of the Village of Chauncey directs the Board of Elections of Athens County to submit the ballot to the electors of the Village of Chauncey in the form set forth below:
