VILLAGE ADMINISTRATOR'S REPORT

Ellis Avenue set to be paved.

New truck has arrived. Village Administrator has the paperwork for the truck and it will be turned over to Fiscal Officer once the vehicle is tagged.

Park agreement was set. A company out of Pennsylvania received the work. A meeting will be scheduled soon. Project is set to start this fall.

Fire Hydrant has been installed on Mill Street. Also, two eatch basins were installed at the same time. Two property's on Mound owned by Bob Johnson had a complaint on how high the grass is. Village Administrator called the property owner and stated that they would get the grass mowed soon.

Maps for Village will be done, when completed they will be computerized and digitalized. Village Administrator walked around with the lady from GIS to get the maps started.

Bill Hunter would like the agreement language changed on Mill Street. Solicitor is aware of the changes and Solicitor will make the changes to the agreement. Council approves the changes to be made by the Solicitor.

Sewer line on Converse street was not bid on again. HAPCAP recommends to hold it until spring then have it re-bid. Commissioner's may add more funds in the spring. Council is okay with waiting till spring for it to be re-opened for bid.

Village Administrator will be having a snowplow put on the new truck. The cost of the plow will be around \$10k.

SOLICITOR'S REPORT/OPEN ITEMS

The village must designate a space for mobile homes within the village per the state guidelines. The village does have a space within the village limits for mobile homes.

Tammy hawk made a motion to have Johnathan Robe be the assistant solicitor, seconded by Diana Burritt, AIF

MAYOR'S REPORT

Received a grant for additional park improvement through Ohio Department of Natural Resources. Mayor applied back in June and we did receive the funds.

47 Main Street = Village Administrator issued a letter to David Funk and the work will need to be done within 180 days.

Mayor is still waiting on paperwork from 6 other David Funk properties.

Mayor sent an email to the Solicitor about the properties on Smith Street. Mayor and Solicitor/assistant Solicitor will discuss the properties. Once a decision is made, a letter will be sent to the property owner about what needs to happen with the property.

State funding for the water funds has started being announced and the Village of Chauncey is not on the list. There is still \$100 million left to be announced.

Mayor met with Sherrod Brown's staff and they are in support of the sewer projects.

Mayor asked solicitor about getting old bills off of the record so no bills being printed are old and outdated. Need to check with the company about how to get the bills off of there. Tracic is also checking on a new water billing software for the Village.

DLZ project update: DLZ has got all of the surveys done and now are starting to work on the next steps.

AML grant is set to demolish all of the old mine buildings still left in the Village. The Planning Commission is looking at getting funding to get the homes saved and for them to remand standing.

COUNCIL MEMBERS REPORTS

Diana Burritt - Nothing

Connaught Cullen - The county home has a big recycle bin. Has the village received anything about recycling in the village? Mayor and Village Solicitor are going to schedule a meeting with the county recycling center.

Tammy Hawk - Will not be here in December.

Evelyn Nagy - Disappointed in not receiving any permits for use of the park. There will be three seats available for council in January. How does this process work?
