The President of Council shall continue to be a signatory on the Village checking and other accounts during his tenure as President of Council but not after his term of office ends on December 31, 2020.

Section Three:

The Fiscal Officer is authorized to notify the Hocking Valley Bank in writing of any continuation of or change in the status of John Canter as President of Council.

Section Four:

This Resolution is an emergency measure necessary for the proper operation of Village administration and payment of ongoing daily expenses, goods and services provided to the Village and is necessary for the protection of Village residents' health, safety and welfare, through the provision of Village
