RESOLUTION NO. 2021- 27**

**A RESOLUTION AMENDING RULE NO. 44 OF THE RULES OF
COUNCIL**

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Chauncey, State of Ohio, as follows:

Section One: RULE NO. 44 of the Rules of Council is amended to read as follows:

44. EXPULSION


Council shall determine the qualifications of it's own members and may, by appointed committee or otherwise, investigate any credible allegation of disqualification. It may punish or expel any member for disorderly conduct or violation of it's rules or violation of law. Council may by two-thirds (2/3) vote declare a Council seat vacant for absence without valid excuse, where such absence has continued for two consecutive meetings. No permanent expulsion or vacation because of absence shall take place without the concurrence of two-thirds (2/3) of all members elected, and until the delinquent member has been notified of the charge against him/her and has had the opportunity to be heard. See RC 731.44 and 731.45.

Section Two: It is the purpose of this Resolution to provide for the safety, health and welfare of the residents of the Village by maintaining a full membership of the Council therefore, this Resolution is declared to be an emergency measure necessary for the uninterrupted and representational governance of the Village for the protection of the safety, health and welfare of the residents and travelers within the Village. ORC 705.15 and 731.17.

Section Three: The Resolution three reading requirement is suspended and waived as provided in ORC 701.15 and 731.17. This Resolution shall take effect immediately upon passage.




