**Ordinance and Resolutions:**

**ORDINANCE 2025-06** An Ordinance Allowing for a 3% Inflationary Increase for Sewer Rates over the next 3 Years. (2nd Reading). Karla Dellinger: I called around to see rates in the area, we are about middle of the pack. Karla will send out those rates. Albany is the most expensive, they have a \$10 charge for when they had to replace the water system. Karla Dellinger believes that the 3% is warranted. Evelyn Nagy: The people I have spoke to in the village are not really happy. Mike Kraus: If we assume our pricing model to break even, our operating cost is going up. Tammy Hawk: I want to be known once Chris gets his license, he should be given a raise since he is doing two jobs. Village Comment: How much will that generate for the village? Fiscal officer, based on what we have received through October 31, it would generate roughly \$6,000.

**RESOLUTION 2025-22** A Resolution to Enter into a Contract for the Employment of a Solicitor (Jonathan E. Robe). (2nd Reading). No comments

**RESOLUTION 2025-21** A Resolution Accepting the Reasonable Accommodation Policy and 504 Grievance Policy. (2nd Reading). Connaught Cullen: Why do we have to do this if it is required? Mayor: If we don't do it, then we could possibly lose grant funding.

**RESOLUTION 2025-25** A Resolution for Holiday Bonuses for 2025. Karla Dellinger made the introduction, seconded by Evelyn Nagy, AIF. Full time: \$ 200.00 Part time: \$ 100.00. Evelyn Nagy would like to declare it an emergency. Karla Dellinger

Dylan Skees made a motion to adjourn, seconded by Karla Dellinger. AIF


