Karla Dellinger asked the Village Administrator about the holes beside the new sidewalks. The Village Administrator has contacted the company in regards to the holes being filled in.

Still waiting on the bids to come back for the sewer line under State Route 13. If someone bids on the project, the village will also put in the sewer tap at Lexington Avenue at the same time so that the road will not need to be closed twice.

The Village Administrator would like to confirm the amount of sewer and water connections for the village. Per ordinance 2021-15 it is \$ 2,000 per connection.

47 Mill (Lisa Taylor) would like to have a sewer tap installed.

The road in the park is going to be fixed. They are going to cut out the bad spots and patch those. When they do the new road, they will make it all even with the bad spots.

## VILLAGE SOLICITOR REPORT

47 Main Street: There was a hearing by the liquor commission regards to the application for the liquor permit. The property owner withdrew his permit during the hearing. The floodplain permit expired in May and the property owner did not do what was required. He will need to re-apply for the floodplain permit.

2 Lexington Avenue: Village Solicitor needs to bring the condemnation form to the Village Administrator.

Structure Point: Buckeye Hill Regional Council: Project Rise. They are working with villages and private property owners. The Village of Chauncey was been selected.
