#### **NEW BUSINESS**

#### RESIDENTS COMMENTS

Bobby Fuller from DLZ = Still working on plan. They are roughly about 50% finished. Believe that they have about 2 months left of work. Waiting on EPA on a Permit to Install. Once that happens, they are "Shovel Ready". Any areas that Village of Chauncey would want to extend its services. Only area of concerns would be to extend to the Abdell Properties. It will be cheaper for the sewer system to get permits for under the railroad for sewage for the park instead of tapping into Spring Street.

# VILLAGE ADMINISTRATOR'S REPORT

39 Ellis is asking to get a separate water tap. What is the price for the second meter? Do we want to assign an address. Council would like to assign the address of 39 ½ for the new water tap.

Demo at the park is in progress.

The Village of Chauncey is going to wait on purchasing a bachhoe.

Rick Wasserman = Has a grant that allows him to tear down houses and the land owner keeps to keep the property. 45 Mill Street is what Rick asked about. It would be up to the Village Administrator or Mayor to take action.

55 Mill Street and 67 Mill Street are the burnt houses. 55 Mill Street owner will allow the land bank to tear it down as long as they get to keep the property. 67 Mill Street has not responded to communication about the land bank tearing it down.

14 and 16 Mound Street = Owner is going to allow the land bank to tear them down as long as they get to keep the property.

93 Converse Street is going to allow the Land Bank to tear the building down.

20 and 22 Smith, owner is trying to get it under condemnation so that the property can be tore down by the Land Bank
