Appalachian Community Grant BUILDS: Mining buildings are in the best shape out of any of the mining buildings that they have inspected in Southeastern Ohio. Park:

Name of the park: 2021-7 Resolution was naming the park "Chauncey Park Trailhead". The reason for the dropping of "Dover" is that they do not contribute to the park. The village is working on the park being annexing the park into the village. The village council would like to see two separate signs, one for the park and one for the trailhead. One will be the village branding and one will be the Baileys Trail System Branding. The village council would like to know where the sign will be located. They feel as if it is not safe at the top of the hill due to it blocking the view to get out of the drive. If Jessie at ORCA agrees, the village would like it moved down the hill instead of at the road. The village would like the signs for the village to follow the village color themes (Blue and White).
