## VILLAGE OF CHAUNCEY STATE OF OHIO ORDINANCE NO. 2022-2

## AN ORDINANCE ESTABLISHING THE SALE OF THE 2004 FORD F350 BY THE VILLAGE ADMINISTRATOR

**WHEREAS**, the Village of Chauncey, Ohio possesses and owns a 2004 Ford F350 village vehicle, and

**WHEREAS**, the Village of Chauncey, Ohio no longer has need of the 2004 Ford F350 village vehicle, and

**WHEREAS,** the estimated value of the 2004 Ford F350 village vehicle is greater than \$1000 so that the sale of the 2004 Ford F350 village vehicle must be authorized by ordinance, pursuant to Ohio Revised Code Section 721.15,

**NOW THEREFORE, BE IT ORDAINED** by the Council of the Village of Chauncey, State of Ohio, as follows:

Section 1: The Village Administrator is hereby authorized to sell the Village's 2004 Ford F350 village vehicle by sealed bid. Sealed bids shall be submitted to the Village office and read aloud at a future council meeting. The Council for the Village of Chauncey may reject the bid for the vehicle if it believes the vehicle is worth more than the highest bidder.

<u>Section 2</u>: It is the purpose of this Ordinance to expedite the disposal or sale of obsolete Village property and/or equipment and at an appropriate price, therefore this Ordinance is deemed an emergency measure necessary to protect the health, safety, and well-being of the Village residents and shall take effect immediately upon passage.

This Ordinance is passed on an emergency measure and the suspension of the three readings requirement set forth in ORC 731.17 by vote of three-fourths of Council members and shall take effect immediately upon passage.
