**A RESOLUTION AUTHORIZING THE MAYOR TO SIGN A  
PURCHASE AGREEMENT WITH THE ATHENS COUNTY  
LAND REUTILIZATION CORPORATION TO PURCHASE 72  
AND 74 MAIN STREET**

**WHEREAS**, the Athens Land Reutilization Corporation has offered to sell the properties located at 72 and 74 Main Street, Chauncey, OH, 45719 to the Village of Chauncey for one dollar, and

**WHEREAS**, the Village is desirous to acquire such property to use as the Village sees fit for the further growth and development of the Village,

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Village of Chauncey, State of Ohio, as follows:

**Section 1.** The Mayor is hereby authorized to sign a Purchase Agreement with the Athens County Land Reutilization Corporation for the purchase of the properties located at 72 and 74 Main Street, Chauncey, OH, 45719. A copy of the Purchase Agreement is attached hereto and is incorporated herein by reference.

**Section 2.** The Fiscal Officer is hereby authorized and directed to pay \$175.00 in closing costs for the purchase of the properties located at 72 and 74 Main Street, Chauncey, OH, 45719.


**Section 3.** It is the purpose of this Resolution to continue without delay the acquisition of the properties located at 72 and 74 Main Street, Chauncey, OH, 45719 to ensure that the Village obtain ownership of those properties, therefore this

Resolution is deemed an emergency measure necessary to protect the safety, health and welfare of the Village residents and shall take effect immediately upon passage.

This Resolution is passed on suspension of the three readings requirement set forth in ORC 731.17 by vote of three-fourths of Council members, and shall take effect immediately upon passage.


