RESOLUTION NO. 2022-8**

**A RESOLUTION AUTHORIZING THE MAYOR TO NEGOTIATE WITH  
THE OUTDOOR RECREATION COUNCIL OF APPALACHIA (ORCA)  
AND AUTHORIZING THE MAYOR TO SIGN THE JOINT USE  
AGREEMENT FOR THE PARK FUNDS AND IMPROVEMENTS**

**WHEREAS**, the Village of Chauncey, Ohio owns and operates public park facilities within the village limits for the use of village residents, and

**WHEREAS**, public park facilities are in need of maintenance and improvement, and

**WHEREAS**, it is in the interest of the Village of Chauncey and for the benefit of the residents of the Village for the Village to enter into a joint use agreement with the Outdoor Recreation Council of Appalachia (ORCA),

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Village of Chauncey, State of Ohio, as follows:


Section One: The Mayor is hereby authorized to negotiate and sign a joint use agreement with ORCA for park funds and improvements. A copy of the Joint Use Agreement is attached hereto as **Exhibit A.**

Section Two: It is the purpose of this resolution to provide for the proper maintenance and improvement of village public park facilities, and a joint use agreement between the Village and ORCA is necessary for such maintenance and improvement, this measure is deemed an emergency measure to protect the health, safety, and welfare of Village residents and park facility users.

This Resolution is passed on suspension of the three readings requirement set forth in ORC 731.17 by vote of three-fourths of Council members and shall take effect immediately upon passage.




