VILLAGE OF CHAUNCEY STATE OF OHIO ORDINANCE NO. 2023-5

AN ORDINANCE TO AMEND THE FLOODPLAIN ORDINANCE TO DESIGNATE THE CODE INSPECTOR AS FLOODPLAIN ADMINISTRATOR

WHEREAS, special flood hazard areas exist within the Village that are subject to periodic inundation which may result in loss of life and property, health and safety hazards, disruption of commerce and governmental services, extraordinary public expenditures for flood protection and relief, and impairment of the tax base; and

WHEREAS, structures that are inadequately elevated, floodproofed, or otherwise protected from flood damage also contribute to the flood loss; and

WHEREAS, the Village adopted Ordinance 2022-17 to implement and establish proper floodplain regulations to minimize the threat of flood damage and loss; and

WHEREAS, Ordinance 2022-6 established the Chauncey Zoning Code which established the Office of Code Inspector to enforce the Chauncey Zoning Code; and

WHEREAS, efficient administration of Village law and regulations would best be accomplished by designating the Code Inspector as Floodplain Administrator,

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Chauncey, State of Ohio, as follows:

Section 1. Section 3.1 of Ordinance 2022-17 is hereby amended as follows:

3.1 DESIGNATION OF THE FLOODPLAIN ADMINISTRATOR

The Village Administrator Code Inspector of the Village of Chauncey or his/her designee is hereby appointed to administer and implement these regulations and is referred to herein as the "floodplain administrator." The Village Administrator shall serve as the Floodplain Administrator in the absence of the Code Inspector.

Final version as amended:

3.1 DESIGNATION OF THE FLOODPLAIN ADMINISTRATOR

The Code Inspector of the Village of Chauncey or his/her designee is hereby appointed to administer and implement these regulations and is referred to herein as the "floodplain administrator." The Village Administrator shall serve as the Floodplain Administrator in the absence of the Code Inspector.

Section 2. It is the purpose of this Ordinance to continue without interruption the administration and enforcement of the Floodplain Management Ordinance and therefore this Ordinance is deemed an emergency measure necessary to protect the safety, health and welfare of the Village residents and shall take effect immediately upon passage.

This Ordinance is passed on suspension of the three readings requirement set forth in O.R.C. 731.17 by vote of three-fourths of Council members, and shall take effect immediately upon passage.
