MAYORS REPORT

OPWC grants are going to be closing. We have about 100k in permissive tax funds. I have reached out to DLZ about paving the roads next year once the projects are finished in the village.

Chauncey AHEAD

We submitted a pre-application to the Appalachian Regional Commission for site utilities on the Chauncey AHEAD property. If accepted, they will invite us to apply. We are also exploring submitting an ODNR AMLER application to build a spec building for a future commercial company to then occupy. DLZ is currently mapping out possible layouts for the site.

ORCA Update

I'm currently serving on the hiring committee for ORCA to hire a newly designed position for Finance Administrator, similar to a Fiscal Officer position. It's a redesign from the former Finance Director position which became vacant. It will save ORCA some funds annually to have this alternative position. Athens seems poised to pay their annual membership fee once their

reserve funds recover which is expected in July. Buchtel's trailhead is currently under design and it's looking really cool.

VILLAGE ADMINISTRATOR

I have been working with the contractors for the sewer project most of the time. They are a good company to work with and have been working well with us.

VILLAGE SOLICITOR

Natureworks: We did receive a Memorandum of understanding that I am currently working on.

Connaught Cullen: Do we need to have a liability agreement for our mural that is going to be painted? Solicitor: Yes, I will work on this and get it to you.

REPORTS FROM COUNCIL

Tammy Hawk: I am still involved in the transportation committee. I will be meeting with them surrounding our transportation. I would like to find a time to talk about the income tax for Chauncey so we can hire an administrator to take care of some items. The village lost an alley to the school parking lot. Is there anything we can do to reclaim the alley? The Village Administrator believes we told them they could pave it but we were not aware they were putting parking spots there.

Connaught Cullen: The pile of bricks, are we still selling them? Mayor Amy would like to keep them so that we can use them back in the village.

Mike Kraus: The party in the park was a huge success and I enjoyed my time. Is there any plans for the 4th of July. Mayor Amy: I'm not sure we have the funds or the time. Fiscal Officer: Can we look at investing some of our money into short-term CD's? Fiscal Officer will look into it.

Dylan Skees: Are we allowed to paint the power poles? We will have to ask the companies.

PUBLIC COMMENTS

Barb: The village does have it on their website for a July 4th party. Amy: We are waiting on a reply. There is a pot hole on 4th street just an FYI. If they do one traffic down State Route 13, will it be stop lights or what? Village Administrator: It will be stop lights.

Fauna: Where is the mural going to be? On the side of the village hall. When will the ground be broken on the new library? Mayor Amy: They do not have all the funding they want. They are continuing to try to get additional funding.
