A RESOLUTION AUTHORIZING THE MAYOR TO APPLY FOR AND ACCEPT ODOT TAP GRANT FUNDS FOR PEDESTRIAN AND VEHICLE ACCESS TO THE VILLAGE PARK

WHEREAS, it is necessary for the Village of Chauncey to provide for safe pedestrian and vehicle access over the railroad tracks to the Village Park; and,

WHEREAS, ODOT Transportation Alternatives Program ("TAP") Grant funding may be available to cover the cost of providing for safe pedestrian and vehicle access to the Village park, and

WHEREAS, Council finds it necessary and appropriate and in the best interest of the City to authorize the Mayor to apply for and receive TAP grant funding,

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Chauncey, State of Ohio, as follows:

Section 1. The Mayor is hereby authorized and instructed to apply for ODOT TAP Transportation Alternatives Program Grant funding to provide for safe pedestrian and vehicle access to the Village Park, including access over and across the railroad tracks.

Section 2. The Mayor is hereby authorized to take any steps reasonably necessary to apply for and receive ODOT TAP grant funds, including, but not limited to, a grant agreement with ODOT or other applicable agencies of the State of Ohio.

Section 3. It is the purpose of this Resolution to enable the Village to obtain necessary grant funding for safe access to the Village park for pedestrians and at grade vehicular crossing, therefore this Resolution is deemed an emergency measure necessary to protect the health, safety, and well-being of the Village residents and shall take effect immediately upon passage.

This Resolution is passed on suspension of the three readings requirement set forth in ORC 731.17 by vote of three-fourths of Council members, and shall take effect immediately upon passage.
