A RESOLUTION AUTHORIZING THE MAYOR_ TO APPLY FOR, ACCEPT, AND ENTER INTO A WATER POLLUTION CONTROL LOAN FUND (WPCLF) AGREEMENT ON BEHALF OF THE VILLAGE OF CHAUNCEY FOR PLANNING, DESIGN AND/OR CONSTRUCTION OF THE SEWER COLLECTION REPLACEMENT PHASE 2 WASTEWATER FACILITIES; AND DESIGNATING A DEDICATED REPAYMENT SOURCE FOR THE LOAN:

Whereas, the VILLAGE OF CHAUNCEY seek to upgrade its existing wastewater facilities; and

Whereas, the **VILLAGE OF CHAUNCEY** intends to apply for **Water Pollution Control Loan Fund (WPCLF)** for the planning, design and or construction of the *Sewer Collection Replacement Phase 2 Wastewater* facilities; and

Whereas, the Ohio **Water Pollution Control Loan Fund (WPCLF)** requires the government authority to pass legislation for application of a loan and the execution of an agreement as well as designating a dedicated repayment source; now therefore,

BE IT RESOLVED by the Council of the VILLAGE OF CHAUNCEY, Ohio:

SECTION 1. That _the Mayor_ be and is hereby authorized to apply for a **WPCLF** loan, sign all documents for and enter into a **Water Pollution Control Loan Fund (WPCLF)** with the Ohio Environmental Protection Agency and the Ohio Water Development Authority for planning, design and/or construction of **wastewater** facilities on behalf of the **VILLAGE OF CHAUNCEY**, Ohio.

SECTION 2. That the dedicated source of repayment will be **SEWER USER FEES_**.

SECTION 3. That is resolution shall take effect and be in force from and after the earliest period allowed by law.
