A RESOLUTION AUTHORIZING THE MAYOR TO APPOINT DREW DANIELS AS CODE INSPECTOR OFFICER TO ADMINISTER THE CHAUNCEY ZONING CODE AND DECLARING AN EMERGENCY

WHEREAS, the Council, by Resolution 2023-6 authorized the Mayor to interview candidates for the position of Code Inspector to enforce the Zoning Code in accordance with the administrative provisions of the Zoning Code and to hire the candidate the Mayor determines to be the most qualified and suitable; and

WHEREAS, the Mayor duly interviewed qualified candidates and determined that Drew Daniels was the candidate most qualified and suitable to be hired as Code Inspector Officer and so hired Mr. Daniels; and

WHEREAS, there is an immediate need for the Village of Chauncey to seek out and hire a suitable person to serve as Code Inspector Officer to enforce the Zoning Code,

NOW THEREFORE, IT IS RESOLVED BY THE COUNCIL OF THE VILLAGE OF CHAUNCEY AS FOLLOWS:

Section 1. The Mayor is hereby authorized to hire Drew Daniels as Code Inspector Officer to enforce the Zoning Code in accordance with the administrative provisions of the Zoning Code. Mr. Daniels shall serve as Code Inspector and provide 10 hours of work per week in such capacity.

Section 2. The Mayor's previous hiring and appointment of Drew Daniels to the Office of Code Inspector is hereby ratified and adopted as if done by Council. The compensation for Mr. Daniels for his service in such office shall be in accordance

with and as provided by law. Mr. Daniels shall be compensated for his services rendered as of the date of the Mayor's appointment and hiring.

Section 3. This Resolution is declared to be an emergency measure because it is necessary to health, safety, and welfare of the Village that the Village be able administer and enforce its Zoning Code to encourage and protect the value of the various properties located in the Village and to protect the property rights of each property owner.

This Resolution is passed on suspension of the three readings requirement set forth in ORC 731.17 by vote of three-fourths of Council members, and shall take effect immediately upon passage.
