EVELYN NAGY moved the adoption of the following Resolution:

WHEREAS, the amount of taxes which may be raised within the ten mill limitation will be  
insufficient to provide an adequate amount for the necessary requirements of the said  
subdivision, VILLAGE OF CHAUNCEY, County of Athens;  
(City or Village Council, Board of Commissioners, Trustees or Education)

RESOLVED, by the VILLAGE COUNCIL of the members elected thereto  
(City or Village Council, Board of Commissioners, Trustees or Education)

Concurring, that is necessary to levy a tax in excess of the ten mill limitation for the benefit of the  
said subdivision. VILLAGE OF CHAUNCEY  
(Example: City of Athens or Twp. of Troy (Including or Excluding Coolville Village or Territory Covered by The Plains Fire  
Dept.)

RESOLVED, That the question of levying additional taxes be submitted to the electors of said  
Subdivision at the GENERAL election to be held at the usual places within said  
(Primary, General or Special)  
subdivision on NOVEMBER 2, 2021; and be it further.  
(Date of the Election)

RESOLVED, That said levy be placed upon the tax list of the current year after the February  
Settlement next succeeding the election, if majority of the electors voting thereon vote in favor  
thereof; and be it further.

RESOLVED, that the Clerk or Fiscal Officer of the said VILLAGE OF CHAUNCEY  
(City, Village or etc.)

County of Athens, Ohio, notify the Board of Elections to cause notice of election on the question  
of levying said tax to be given as required by law.

## CERTIFICATE OF ESTIMATED PROPERTY TAX REVENUE

The County Auditor of Athens County, Ohio does hereby certify the following:

1. On June 30, 2021, the taxing authority of the Village of Chauncey certified a copy of its resolution or ordinance adopted June 17, 2021 requesting the county auditor to certify the current tax valuation of the subdivision and the amount of revenue that would be produced by Five (5.00) mills, to levy a tax outside the 10-mill limitation for Current Expenses purposes pursuant to Revised Code §5705.19 (A), to be placed on the ballot at the November 2, 2021, General Election. The levy type is a Renewal.
2. The estimated property tax revenue that will be produced by the stated millage, assuming the tax valuation of the subdivision remains constant throughout the life of the levy, is calculated to be \$ 29,480. \*
3. The total tax valuation of the subdivision used in calculating the estimated property tax revenue is \$ 6,874,760.
