Budget: Discussion regarding the Resources - the LB-1 did not save correctly. Some attendees had the correct version and the rest were missing line 3. The Budget Officer was asked several times where the short fall would come from regarding LB-30 line 14. Based on the Adopted Budget of 2017-18 the 'Wish List' money was projected at \$5,500. However, the Library received only \$2,001. There is already one grant coming in for \$3,000. It is already only at 3-4% of the entire budget.
