The Arlington Heights Art Guild will be hosting their 52nd annual fine art fair “**A Walk in the Park**” on **Sunday, August 27th, 2023** at North School Park, 410 N. Arlington Heights Rd., Arlington Heights, IL

\* We will jury all new artists. This is not necessary if you participated in previous Walk in the Park fairs. Submit 3 photos via mail or email 3 images of your work to Linda Campuzano [carlin55@att.net](mailto:carlin55@att.net) See address below if mailing.

\* **All art work must be the original work of the artist. No buy/sell, manufactured or commercial products are permitted. Otherwise you will be asked to leave.** Reproductions or prints are to be labeled as such.

\* Deadline for applications is June 1, 2023. Accepted artists will be notified after review of the application. We are located at a beautiful park in downtown Arlington Heights with ample free parking. This fair is heavily advertised and well known in the area. In previous years we had approximately 90 artists and this one day show drew an attendance of over 2500.

\* Most sites are 12' x 12' and will be assigned as entries are processed. You must supply your own 10' x 10' tent, tables and chairs if needed. Artists may begin setting up at 7:00 a.m. Stakes in the ground are prohibited. All artists must attend their own sites and remain until 5:00 p.m. Please note, parking on the street is for everyone's use and there are no reserved parking places in front of your booth.

\* You must leave your vendor space clean of debris at the end of the fair. If you must dispose of something, it must fit into the waste cans located throughout park. If it does not fit in the can, you must carry it out of the park and dispose of it at home. Failure to comply will cause you to lose your opportunity for future participation.

\* Entry fees are \$100 for non members and \$80 for members of the Arlington Heights Art Guild. There are no refunds after August 21, 2023. Make checks payable to the **Arlington Heights Art Guild and mail with your application to: Linda Campuzano 609 Edinburgh Ln, Unit A, Prospect Hts, IL 60070.**
