# ART GUILD 01/18/2024 MEETING MINUTES Wheeling Township Building

<u>Ann Musolf</u>, Vice President: Opened meeting at 7:15 pm nominating Marion Sherman for President of our Guild. Rita Molepske seconded the nomination. All members were asked if there were any other nominations. No other nominations. All members were asked to vote yes for Marion by a show of raised hands. A full quorum of members voted in agreement that Marion Sherman be President of AHAG.

Marion Sherman, President: Thanked all members for their support and confidence in her leadership as President. She spoke of doing her best and, in exchange, requested that each member do their best in volunteering when needed. Board members present at meeting were introduced by Marion: Rita Molepske, Scholarship Chair, Janet Grochocinski, Treasurer, Patti Jostes, Membership Chair, Kathy Stenger, Art Fair Team, Ann Musolf, Vice President, Larry Freson, Art Fair Chair, and Eileen Fogell, Programs & Publicity Chair. Marion also announced that the AHAG BY-LAWS (first created in 1971) have been revised and updated by the entire Board to reflect our Guild as it is currently in 2024. The updated BY-LAWS have been printed and are available in the back of the room for each member to take home and read. At the February meeting all members will be asked to vote on the acceptance of the updated BY-LAWS.

<u>Rita Molepske</u>, Scholarship Chair: Is asking for 2 or 3 more volunteers to judge the annual scholarship art competition for School District 214. Judging will take place on Tuesday, February 13<sup>th</sup> at Elk Grove High School at 3:45 pm. Rita passed out a clipboard during the meeting for members to sign up as judges, and successfully obtained more volunteers. The clipboard information included the address of Elk Grove High School and the criteria for judging.

<u>Janet Grochocinski</u>, Treasurer: Currently AHAG has \$7912.36 in our checking account, \$1556.00 in savings and \$5573.73 in CD's. This comes to a total of \$15,042.57. Janet asked if anyone has an expense coming from the Christmas party, please give her those receipts for reimbursement.

<u>Larry Freson</u>, Art Fair Chair: Announced that he has volunteered to be chairperson for the Guild's annual art fair, "A Walk In The Park". At the February Guild meeting Larry plans to introduce his team of 5 or 6 volunteers who have each volunteered their time to follow through on specific art fair responsibilities. One of the team was present this evening, and Larry introduced Kathy Stenger. Larry is asking each member to consider volunteering to take over his past position as the GUILD TENT CHAIR at the art fair since he cannot handle both chair positions at the same time.

<u>Marion Sherman</u>, President: Thanked Larry for his willingness to step up as Art Fair Chairperson. Larry was also thanked for taking on the Hospitality Chair as well as providing the hot coffee on such a cold night. All members applauded Larry.

<u>Eileen Fogell</u>, **Program & Publicity Chair:** Demo artist, Lindsey Lee Miska, a middle school art teacher who is working with acrylics this evening.
