- <u>Drop and run</u> (for current consignors): Contact us to arrange this option. We will provide the consignor with a week in which to bring **up to 12 items**. We will accept items listed above, *except* furniture. We require up to **5 business days** from the drop date to assess your items; any items not accepted will be donated. Please understand by using this option, you forfeit the ability to have unaccepted items returned to you.
- As a consignor, you agree that items accepted by Then and Now Consignments will remain for sale in the store for 60 days. After that time, you can contact the store to arrange a time to pick up unsold inventory. After 90 days, any remaining items will be donated.
- As a consignor, you are responsible for keeping track of your items, and ensuring we have your current mailing address, phone number, and email address.

If you cancel your appointment or do not drop items during your agreed upon week, rescheduling will be subject to availability. Our goal is to treat all our consignors fairly and equally. We take exceptional care of your items; however, merchandise is consigned at YOUR OWN RISK.

Pricing and Payment Information:

- Items will be priced by *Then and Now Consignments*. We will pay the consigner 40% and any items priced over \$65 will be 50/50. Your funds will be available after the item(s) have been sold.
- The price will stay firm for **30 days**. After 30 days, prices are reduced to 25%. After **60 days**, prices are reduced to 50%. Any items remaining after **90 days** will be donated.
- The consignor can collect their money anytime. You can also use your money for store credit.
- If a consignor has been inactive for **1 year**, *Then and Now Consignments* will send your payout in the mail and maintain your account.
- If you (the consignor) lose your check, the store will re-issue a new check upon request. You will be responsible for the stop payment fee for the lost check.
